

Regulations for Online Voting in the Architectural Competition "Mountain Shelter on the top of Jeżowa Woda mountain with Restaurant and Viewing Terraces"

§ 1

General Provisions

1. The Regulations for Online Voting (hereinafter referred to as the "Regulations") for projects within the Architectural Competition "Mountain Shelter on the top of Jeżowa Woda mountain with Restaurant and Viewing Terraces" (hereinafter referred to as the "Competition") define the terms and conditions for casting votes for participants in the Competition's II stage (hereinafter referred to as the "Voting").
2. The Title Winner will be awarded to the architectural design that receives the highest number of votes from participants during the period designated by the Organizer.
3. The Voting in the Competition is organized and monitored by the Competition's organizer - IDEANOVA Foundation with its registered office at 30-102 Kraków, ul. Syrokomli 3/1 (hereinafter referred to as the "Organizer").
4. In matters not regulated by these Regulations, the provisions of the Regulations for the Architectural Competition "Mountain Shelter on the top of Jeżowa Woda mountain with Restaurant and Viewing Terraces" shall apply.
5. The Regulations for Online Voting have been prepared in both Polish and English languages.

§ 2

Voting Rules

1. The Title Winner will receive the architectural design that receives the highest number of votes from participants during the period designated by the Organizer.
2. The voting process is confidential and conducted using a form prepared by the Organizer, accessible on the website: <https://mountainshelter.ideanova.org.pl/>.
3. Each user can cast one vote, only for one selected project.
4. Votes can be submitted on the website: <https://mountainshelter.ideanova.org.pl/>. Once a vote is cast, the IP data of the device used will be blocked, preventing further voting for the same project.
5. The use of vote automation software is prohibited.
6. For verification purposes, the Organizer retains the participant's name, email address, IP address, the exact time and date of vote submission, and the rationale for the project choice. The use of cookies is governed by the Privacy Policy provided on the Organizer's website.
7. In case of observed abuses, the Organizer reserves the right to invalidate votes cast in violation of the Regulations.
8. The voting results will be tallied by the Organizer and approved by the Competition Jury.
9. The Title Winner will be the participant whose project receives the highest number of votes during the voting period.
- 10. Voting takes place from September 14, 2023, at 12:00:00 PM to September 24, 2023, at 11:59 PM (Polish time, GMT + 2:00).** The Organizer reserves the right to change the voting period for valid reasons, which will be communicated on the website: <https://mountainshelter.ideanova.org.pl/> and through the Organizer's social media channels (Facebook, Instagram).

11. The Organizer will publicly announce the name of the winner and the number of votes received during the final gala of the Competition.

§ 3

Final Provisions

1. Casting a vote on the website: <https://mountainshelter.ideanova.org.pl> is equivalent to declaring that the voter accepts the provisions of the Regulations.
2. The Organizer will make every effort to ensure the proper conduct of the Voting.
3. The Organizer reserves the right to terminate the Competition at any time without determining the winner. Information regarding this decision will be provided on the website <https://mountainshelter.ideanova.org.pl> and through the Organizer's social media channels.
4. Both the Voting and the Competition itself are not based on chance and are not subject to the provisions of the Act of November 19, 2009, on gambling (consolidated text: Journal of Laws of 2023, item 227).
5. The Organizer is not responsible for any claims by third parties, particularly arising from the infringement of intellectual property rights, including non-compliance with the provisions of the Act of February 4, 1994, on copyright and related rights (consolidated text: Journal of Laws of 2022, item 2509).
6. In case of any doubts concerning the application of these Regulations, the Organizer has the right to make a binding interpretation of its provisions.
7. Personal data of Voting participants are processed in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as the "GDPR") and the repeal of Directive 95/46/EC (GDPR), as well as the provisions of the Act of May 10, 2018, on the protection of personal data (consolidated text: Journal of Laws of 2019, item 1781).
8. The legal basis for the processing of personal data is:
 - The participant's consent to provide data in connection with participating in the online voting, according to Art. 6(1)(a) of the GDPR, until the consent is withdrawn,
 - The legally justified interest of the Data Controller according to Art. 6(1)(f) of the GDPR, to the extent necessary for defending claims and asserting the rights of the Data Controller in connection with data processing and organizing online voting, not longer than 6 years from the end of the online voting.
